I asked him to try one additional time after this first initial round of gifts came in, to see if any of the players will fill out surveys. If they choose not to do so, we are going to let it go at that. We will not ask Demetrius to, or we will not hound the players to fill out the surveys. I told him I should be the only one requesting any information in reference to the buddy program, as he is extremely busy, and would like to cut down on the number contacts he has to make about his given duties. If you are a member that does not have a completed survey, you can just get general random gifts (Gatorade, coconut water, Cliff Bars, Quest Bars, beef jerky, popcorn, etc.) for the remaining home stands.
